

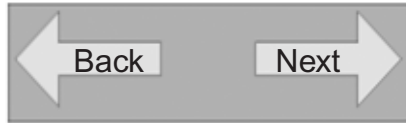
HOW TO VOTE ON A TOUCH SCREEN VOTING MACHINE

INSERT your voter card in the yellow slot on the bottom left of the voting machine.



TOUCH the CIRCLE next to your choice and a green check mark will appear.

TO CHANGE YOUR VOTE, touch the same circle again, then the circle for the choice you want.



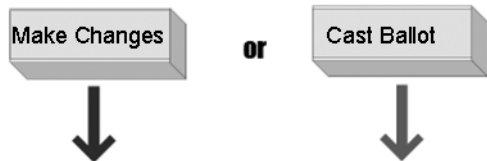
CONTINUE to the following page by touching NEXT or BACK to return to the previous screen.

REVIEW your choices at any time by touching the REVIEW square.



PRINT a paper record of your ballot selections by touching the yellow square at end of the ballot.

The printout stays on the machine and is used for audit purposes.



To make changes on your ballot To cast your ballot

RETURN YOUR VOTER CARD to an election worker after your ballot is cast and the voting machine ejects it.

**REASONS FOR DEMANDING THE RECALL
OF GERALD ANTINORO**

Sheriff Antinoro should be recalled. He has a track record of mistreating women. An independent sexual harassment investigator hired by Storey County found that Antinoro engaged in multiple acts of sexual harassment. The County scheduled sexual harassment training because of his conduct, but he skipped it.

Antinoro's personnel decisions have cost the County \$144,000 in settlements with former employees, plus thousands of dollars in time for staff at the County to handle numerous claims by his employees.

He stipulated with the Ethics Commission to settle a charge of using his office to obtain unwarranted personal benefits during the 2014 election. Recently, a panel of the Ethics Commission determined just and sufficient cause existed to refer a second charge to the full Commission for adjudication. This alleged violation of the ethics laws relates to his use of official Sheriff's stationery to endorse a political candidate.

Antinoro was incompetent in handling the Judy Black homicide scene and investigation, prema-

turely calling it an accident. He mishandled evidence, which required the DA to exhume the remains in order to retrieve critical evidence for a murder trial.

We deserve a Sheriff who protects and serves the citizens, not himself. Recall Sheriff Antinoro.

**GERALD ANTINORO JUSTIFICATION OF
HIS COURSE IN OFFICE**

The recall is based on misrepresentations and fabrications! My budget is not out of control, there has been no harassment of employees, and there is no incompetence. This same group has said these same things since the 2014 election. This is their manufactured storyline they continually repeat in hope they can convince people in the absence of proof.

This group of people is trying to buy the Office of the Sheriff because they cannot buy me. They feel they are entitled to special treatment because of who they are, how long they've lived here, or how much money they have.

Special interests should not dictate who your elected officials are. The people of Storey County have elected me to the Office of sheriff twice, now big interest (TRIC) and those who feel they're entitled want to steal your voice. You deserve better!
