Interest was received from both of these groups and we applied to the SERC to send 25 individuals to this training under the HMEP Training Grant. Cherie Nevin advised that Wal-Mart, NV Energy and Nevada EPA committed to attend. This grant was submitted to the SERC on June 7, 2010. Chairman Curtis further suggested that we will have a couple of open slots and he would like to see a representative from the Tahoe Reno Industrial Center General Improvement District attend as well as someone from the County's Community Development Department.

Chairman Curtis further stated that Storey County LEPC is handling the grant to support the Fire Shows Reno Hazmat Program.

Chairman Curtis then called for a motion to approve the HMEP Training Grant for the 2010 Cycle.

Motion for approval of the HMEP Training Grant to send 25 individuals to the Fire Shows Reno Hazmat Training Program in October 2010 was made by Pat Whitten. This motion was seconded by Gary Hames. All present in favor. Motion carries.

County Manager Pat Whitten thanked Joe Curtis and Cherie Nevin for their work on the United We Stand Grant.
